Qualification Objectives

What does this qualification cover?

The objective of these qualifications is to provide learners with a re-assessment of the skills required to take command at a fire and rescue incident at initial, intermediate, advanced or strategic level.

These qualifications align with the NFCC Incident Command National Operational Guidance (NOG).

Who is the qualification for?

This qualification is aimed at qualified firefighters who have previously achieved an award in Initial / Intermediate / Advanced / Strategic Incident Command and are required to revalidate their skills.

Who supports this qualification?

The qualification has been developed in collaboration with Fire and Rescue Services, the National Fire Chiefs Council (NFCC) and training providers in the sector.



Qualification Progression

What future education could this qualification lead to?

Following successful performance at incident command at a given level the learner can progress onto the next level award.

What future employment could this qualification lead to?

These qualifications demonstrate that learners continue to demonstrate the skills to take on the role of Incident Commander at the appropriate level.



Qualification Achievement

What are the entry requirements for the qualification?

Prior to registration learners are required to be:

- accurately identified
- at least 18 years of age
- a qualified firefighter

How is the qualification achieved?

These awards consist of one mandatory unit. The learner will need to complete the mandatory unit at the appropriate level.

What will be assessed?

The units contain the learning outcomes and the assessment criteria that the learner is to be assessed against.

All learning outcomes within the qualification will be assessed.

How will it be assessed?

Each qualification contains one mandatory unit to be completed by the learner. Each unit is comprised of a number of learning outcomes and assessment criteria which must all be achieved.

Learning outcomes that begin 'The learner will understand...' will be assessed through theory-based activities.

Learning outcomes that begin 'The learner will be able to...' are assessed through practical activities.

For example:

Learning outcomes

The learner will...

1. Be able to evaluate the status of an operational incident

2. Be able to review a response to an operational incident

Assessment criteria

The learner will...

1.1 Gather information from available sources to gain accurate situational awareness and understanding

1.2 Analyse the relevant factors prior to taking command of operational incidents

1.3 Determine the effectiveness of the current command team

1.4 Evaluate the status, direction and actions of the tactical plan to support the existing Commander

2.1 Conduct a post incident debrief

2.2 Measure performance against agreed standards relevant to defined roles

2.3 Identify opportunities to improve future personal, team and organisational performance

2.4 Record the review process



Qualification Delivery

What facilities and/or equipment are needed to deliver this qualification?

The approved centre is required to have:

- one or more delivery sites with facilities to support the programme of training and assessment
- equipment in place to facilitate the full programme of learning and assessment
- opportunities for learners to carry out tasks/activities which allow them to generate evidence to meet assessment criteria.

What workforce is needed to be able to deliver this qualification?

The approved centre is required to have a qualified and competent qualification workforce in place which includes as a minimum:

- Head of Centre
- Centre Coordinator
- Assessor(s) and Internal Quality Assurers (IQA) who:
 - Are occupationally knowledgeable in incident command in fire and rescue services
 - Have current occupational competence in incident command in fire and rescue services
- Assessors who are:
 - Qualified with a recognised assessor qualification, or
 - Working towards a recognised assessor qualification, or
 - Able to prove equivalent competence through training to appropriate national standards
- IQA(s) who are:
 - Qualified with a recognised IQA qualification, or
 - Working towards a recognised IQA qualification, or
 - Able to prove equivalent competence through training to appropriate national standards
