### How is the qualification achieved?

The learner will need to complete 9 mandatory units. This will include building portfolio of evidence meeting the assessment criteria.

### What will be assessed?

Portfolio of evidence and demonstration of skills either in the training environment or in the workplace.

### How will it be assessed?

This qualification contains 9 mandatory units to be completed by the learner. Each unit is comprised of a number of learning outcomes and assessment criteria which must all be achieved.

Learning outcomes that begin 'The learner will understand...' will be assessed through theory-based activities.
