



Award in Emergency Response Driving High-Speed (Re-Assessment)

The introduction of Section 19 of the Road Safety Act (2006) to replace section 87 of the Road Traffic Regulation Act (1984) covers exemptions from speed limits for emergency service vehicles and affects those working in the police, fire and ambulance services as well as authorised agencies. This qualification is aimed at those who have previously completed a training course to drive a vehicle under emergency response conditions at high-speed and must take place within 5 years of the initial course training or previous re-assessment.

Qualification Objectives

What does this qualification cover?

The objective of this qualification is to re-assess the learner to ensure that they are still competent to drive a vehicle under emergency response conditions at high-speed, safely, and systematically, and are able to claim legal exemptions in accordance with legislation.

Who is the qualification for?

The qualification is aimed at those who have previously completed a training course to drive a vehicle under emergency response conditions at high-speed and must take place within 5 years of the initial course training or previous re-assessment.

Who supports this qualification?

This qualification has been developed with Emergency Response Driving Training (ERDT) Limited and is based on the Police System of Vehicle Control ("Roadcraft") and written in line with NFCC Emergency Response Driver Framework. The qualification meets the legal requirements of Section 19 of the Road Safety Act 2006 and standards of the draft Road Traffic (training courses at high speed) Training Regulations 2020.



Qualification Progression

How long is the qualification valid for?

Having completed and achieved the SFJ Awards Level 3 Award in Emergency Response Driving High-Speed (Re-Assessment), all learners are required to maintain their ERD-HS competency and be re-assessed every 5-years via the SFJ Awards Level 3 Award in Emergency Response Driving High-Speed Re-Assessment.

What future education could this qualification lead to?

Following successful completion of the qualification, learners can progress to the Emergency Response Driving Instructor (ERDI) course.

What future employment could this qualification lead to?

This qualification re-assesses the individual's knowledge and skills to be able to drive a vehicle under emergency response conditions in exceed of speed limits.



Qualification Achievement

What are the entry requirements for the qualification?

Prior to registration learners are required to be:

- accurately identified
- at least 18 years of age
- must hold a full valid UK driving licence for the class of vehicle being driven
- must have previously completed a training course to drive a vehicle under emergency response conditions at high-speed (within 5 years)
- must provide evidence that they have completed the centre's Emergency Response Driving E-Learning training package
- pre-read the Police System of Vehicle Control ("Roadcraft") manual, all relevant road traffic law and regulations, the Highway Code and their organisational policy regarding emergency response driving

How will it be assessed?

The qualification structure allows learners to select the pathway which applies to the class of vehicle they are required to drive. Each pathway contains 3 mandatory units to be completed by the learner.

Each unit is comprised of a number of learning outcomes and assessment criteria which must all be achieved.

Learning outcomes that begin 'The learner will understand...' will be assessed through theory-based activities.

Learning outcomes that begin 'The learner will be able to...' are assessed through practical activities.

For example:

Learning outcomes

The learner will...

1. Be able to carry out a daily vehicle safety inspection
2. Be able to carry out vehicle pre-use checks

How is the qualification achieved?

This qualification is made up of 3 pathways.

The pathways available are:

1. Emergency Response Driving High-Speed (Re-Assessment) – Class 2 ERD-LV Pathway
2. Emergency Response Driving High-Speed (Re-Assessment) – Class 3 ERD-MV Pathway
3. Emergency Response Driving High-Speed (Re-Assessment) – Class 4 ERD-HV Pathway

Learners must complete 3 mandatory units depending upon the vehicle pathway they have previously been trained in.

What will be assessed?

- Multiple Choice Examination
- Question and Answer
- Practical Assessment/ Direct Observation

Assessment criteria

The learner will...

- 1.1 Carry out a daily vehicle safety inspection
- 1.2 Confirm the equipment required to be with the vehicle is present and in working order
- 2.1 Complete accurate documentation as required relating to the vehicle use
- 2.2 Perform a vehicle cockpit drill



Qualification Delivery

What facilities and/or equipment are needed to deliver this qualification?

The approved centre is required to have:

- one or more delivery sites with facilities to support the programme of training and assessment
- equipment in place to facilitate the full programme of learning and assessment

The approved centre is required to have a qualified and competent qualification workforce in place which includes as a minimum:

- Head of Centre
- Centre Coordinator
- Assessor(s) and Internal Quality Assurers (IQA) who:
 - Are occupationally knowledgeable
 - Have current occupational competence
- Assessors who are:
 - Qualified with a recognised assessor qualification, or
 - Working towards a recognised assessor qualification, or
 - Able to prove equivalent competence through training to appropriate national standards
- IQA(s) who are:
 - Qualified with a recognised IQA qualification, or
 - Working towards a recognised IQA qualification, or
 - Able to prove equivalent competence through training to appropriate national standards
