What are the entry requirements for the qualification?

Prior to registration learners are required to be:

- accurately identified
- at least 18 years of age

How is the qualification achieved?

The learner will need to complete 12 mandatory units. This will include building portfolio of evidence meeting the assessment criteria. What will be assessed?

Assessment for this qualification is through the submission of 12 centre devised assignments, one per unit.

The assignments use case studies, critical scenario analysis, projects, problem solving and policy/programme development tasks.

How will it be assessed?

This qualification contains 12 mandatory units to be completed by the learner. Each unit is comprised of a number of learning outcomes and assessment criteria which must all be achieved.

Learning outcomes that begin 'The learner will understand...' will be assessed through theory-based activities.

Learning outcomes that begin 'The learner will be able to...' are assessed through practical activities.
